Clearstream provides to its customers, among other things, services for safe and settlement of internationally traded securities and securities lending and borrowing. Clearstream interfaces with domestic markets is professional depositary, Clearstream is subject to regulation by the Luxembourg Commission for the Supervision of the Financial Sective recognized financial institutions around the world, including underwriters, securities brokers and dealers, banks, trust companies, clearing organizations and may include the underwriters. Indirect access to Clearstream is also available to others, such as banks, brokers, dealer through or maintain a custodial relationship with a Clearstream customer either directly or indirectly.

We understand that Euroclear was created in 1968 to hold securities for participants of Euroclear and to clear and settle transacti through simultaneous electronic book-entry delivery against payment, thereby eliminating the need for physical movement of certificat simultaneous transfers of securities and cash. Euroclear provides various other services, including securities lending and borrowing and in several countries. Euroclear is operated by Euroclear Bank S.A./ N.V., which we refer to as the Euroclear Operator, under contract w S.C., a Belgian cooperative corporation, which we refer to as the Cooperative. All operations are conducted by the Euroclear Operator, clearance accounts and Euroclear cash accounts are accounts with the Euroclear Operator, not the Cooperative. The Cooperative established Euroclear participants. Euroclear participants include banks (including central banks), securities brokers and dealers, and other profemay include the underwriters. Indirect access to Euroclear is also available to other firms that clear through or maintain a custodial relaparticipant, either directly or indirectly.

We understand that the Euroclear Operator is licensed by the Belgian Banking and Finance Commission to carry out banking act Belgian bank, it is regulated and examined by the Belgian Banking and Finance Commission.

We have provided the descriptions of the operations and procedures of DTC, Clearstream and Euroclear in this prospectus supple convenience. These operations and procedures are solely within







"Significant shareholder" means a person that is the beneficial or power of the outstanding voting shares of the resident domestic corporation. 
Although our board of directors has no present intention of doing so, it could issue a series of preferred stock that could impede offer or other takeover attempt. Our board of directors will issue such a series of preferred stock only if it determines that such an issua and its shareholders. Liquidation. Unless otherwise specified in the applicable prospectus supplement, if we liquidate, dissolve or wind up, then the stock will be entitled to receive, subject to the rights of creditors, but before any such payment to the holders of common stock or any of to the liquidation preference per share set forth in the applicable prospectus supplement. # Miscellaneous

Neither the depositary nor Kohl's will be liable if its ability to perform its obligations under the deposit agreement is prevented of circumstances beyond its control. Both Kohl's and the depositary will be obligated to use their best judgment and to act in good faith in deposit agreement. Each of Kohl's and the depositary will be liable only for negligence and willful misconduct in performing their dution They will not be obligated to appear in, prosecute or defend any legal proceeding with respect to any depositary receipts, depositary shareceive what they, in their sole discretion, determine to be a satisfactory indemnity. Kohl's and the depositary may rely on the advice of their choice. They may also rely on information provided by persons they believe, in good faith, to be competent, and on documents the genuine.


